Voter Challenge Summary

Introduction

This Voter Challenge Summary and accompanying Due Diligence materials are presented alongside the sworn Voter Challenge Form and with reference to RCW 29A.08.810(1)(c)(ii)(A) – (E).

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/ mailing letters and querying online databases as required) and via others (e.g., tracking letters handled by USPS).

This Challenge is not based upon unsupported allegations or allegations of anonymous third parties.

It is noted hearsay evidence is admissible in support of this Challenge. (Ref. RCW34.05.452).

Having exercised due diligence to personally verify the evidence presented on information and belief, following is the factual basis for the Challenge:

* * * *

Background

Registered voters JOHN LOERA, YOB 1958 and KIMBERLY LOERA, YOB 1968, (the “VOTERS”) are registered with a residence address of 101 Angus Road, Pasco WA 99301. There is a separate mailing address on file for the VOTERS in the Voter Registration Database (“VRDB”) of 2045 Sinfonia Avenue, Henderson NV 89052.

History

The Washington Voter Research Project canvassed this address on 5 May 2025. At the time, the canvasser learned the VOTERS did not reside at the residence address listed in the VRDB. The Washington Voter Research Project has learned that the VOTERS’ residence address is in fact 2045 Sinfonia Avenue, Henderson NV 89052.

Affidavit

On 5 May 2025, an affidavit was collected from affiant CONSTANCE LANGDON, certifying that the VOTERS do not reside at the address.

Letter

Letters were mailed via USPS Certified Mail to the addresses on file in the VRDB, notifying the VOTERS that the residence address listed in the VRDB is incorrect. The letters encouraged the VOTERS to update or cancel their voter registrations and included official Washington State voter forms along with contact details for the Franklin County Auditor’s Office.

Data Searches

Data obtained from this source on 6 May 2025 shows the VOTERS with ages consistent with the birthyears listed in the VRDB at the address of 2045 Sinfonia Avenue, Henderson NV 89052. There are multiple addresses in Washington state, including the residence address listed in the VRDB, as well as multiple addresses in California. There are two landline phone numbers with a 509-area code, a code incorporating several cities including Pasco WA. The first, 509-765-9164, is a fax line returning to Moses Lake WA. The second, 509-246-1452, is a number not in service.

Source 2: Cyber Background Checks <https://www.cyberbackgroundchecks.com/>

Data obtained from this source on 6 May 2025 shows the VOTERS with ages consistent with the birthyears listed in the VRDB at the address of 2045 Sinfonia Avenue, Henderson NV 89052. There are multiple additional addresses in Washington state, including the residence address listed in the VRDB, as well as addresses in California. There is no landline phone number with an area code incorporating Franklin County WA.

A Franklin County Property Search conducted on 6 May 2025 shows that there is no real property in Franklin County owned in the name of the VOTERS. The sales history of the registered address 101 Angus Road, Pasco WA shows this property was sold by the VOTERS on 9 June 2023. The Real Estate Excise Tax Affidavit corroborates the sale.

A Clark County Property Search conducted on 6 May 2025 shows 2045 Sinfonia Avenue in Henderson NV is currently owned by the VOTERS.

As of 1 May 2025, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows John Loera with a birthyear of 1958 and Kimberly Loera with a birthyear of 1968 with a residence address of 101 Angus Road, Pasco WA last voted on 8 November 2022.

The VOTERS most recently voted in Nevada on 5 November 2024.

Conclusion

An affidavit was obtained attesting that JOHN LOERA and KIMBERLY LOERA do not currently reside at 101 Angus Road, Pasco, WA. The data indicates that the VOTERS do not own property in Franklin County, have no operable landline phone number in Franklin County, and are most recently registered to vote in Nevada.

The VOTERS meet the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the VOTERS be cancelled forthwith from the roll or the government show good cause in writing why the VOTERS may not be so cancelled.




